Using the HFRA mission statement as our guide, the Board recently completed our annual priorities building exercise and agreed on 5 priorities as focus areas over the next calendar year. Each topic has subteams that will build out action plans to be reviewed and tracked through regular Board meeting updates so stay tuned for more information.

Top 5 HFRA Board Priorities:

- City Zoning Guidelines Updates
- Parking (with regard to Ad Hoc Committee Recommendations)
- Membership & Member Communications
- Building & Growing Relationships with Fellow Historic District Stakeholders
- Long Term Land Use (ex. Corp Yard, Riverfront)

The Board continues to diligently monitor development within the Historic District, alerting residents to significant developments, such as the proposed Crematorium located in the cemetery next to the Preserve, but more often working to influence the city to improve the diligence and transparency in its development process. Our belief is that a more rigorous and transparent process is a win-win for both parties as it builds trust and reduces the amount of ad hoc communications from residents trying to understand the details around decisions made.

Zoning Code Update:

The HFRA Board is keeping a close eye on the city's efforts to update the current Zoning Codes as it relates to the Historic District. Zoning tells us what uses are allowed, what uses must meet certain standards, and what uses are prohibited. Zoning includes the Entertainment District guidelines established for Sutter Street as well parking standards, building height and size requirements and sets the rules for new and existing buildings in Folsom. HFRA will continue to keep its members informed of any Zoning Code updates.
